

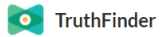

### Where Do Background Check Services Get Their Data?

**The short answer: everywhere.** But in length, they collect data mainly from government data that most search engines cannot find or access. Every time someone updates their driver's license or voting information, that information is logged in government databases with your address (along with previous addresses) as well as other information made available as part of public records.

These background check search engines also crawl the internet for other various data made publicly available, such as social media accounts, dating profiles, blogs, online forums, etc.

### Why Would Someone Use A Background Check Service?

Even though most of the information found by these services are from public databases, these services collect and compile all of this information into comprehensive reports that an everyday person can read without any private eye experience. It also saves you several hours of searching individual databases and search engines for the same information.

### Who Can I Use A Background Check Service On?

Most people use an online background check site to look up:

- Suspected Sex Offenders & Criminals
- New Neighbors, Friends, Or Dates
- Former Classmates
- And More

### Can I Look Up Someone's Credit Using A Background Check Service?

No. Online background check services are NOT credit reporting agencies and are, in fact, prohibited by the Fair Credit Reporting Act (FCRA) from accessing credit information on their

You cannot use a background check service for things like determining a potential employee's or tenant's credit trustworthiness, but you can use them to find other potentially incriminating information (criminal records, sex offender records, etc.).

## How Accurate Are Online Background Check Reports?

Since most of the publicly available data varies from city, state, and county, it ultimately depends on where the person you're searching for lives. Some counties make things more publicly available than others, but that's not to say you can't find the same information elsewhere.

Most of the data will be highly accurate, but it's possible based on these various restrictions that some information will either be missing or not easily disclosed. It's also possible that a report can bring up information on someone else entirely, especially if the person you're looking for has a common name. In this case, you will need to provide super specific details to get an exact match.

## Can You Run An Online Background Check For Free?

Some online background check services allow you to run a search on a free trial, but these free reports tend to be very hollow and lacking in the depth most people need. If you want a thorough and comprehensive report, it's best to pay for one.

Only truly reputable background check companies cost money. The free ones are usually blackhat marketers collecting information on you. Even "free" sites have a price to pay, so it's best to use one that costs a little money.

## What Is The Average Price For An Online Background Check Report?

Each online background check service varies in price, but most of the reputable ones use a subscription-based model, ranging anywhere from 1 month to 1 year (and some even longer).

This model is actually the best value simply for the fact that these subscriptions allow you to run multiple searches without adding any extra cost.
